BALTIMORE -- Olympic gold medal swimmer Michael Phelps avoided jail time on Friday when a judge placed him on probation for pleading guilty to a drunken driving years. The punishment came with a warning.

"You don't need a lecture from the court," Baltimore District Judge Nathan Braverman told Phelps. "If you haven't gotten the message by now, or forget the message, Probation allows the most decorated Olympian ever to focus on training for the 2016 Games in Rio De Janeiro, which would be his fifth. The 29-year-old came out of a set on Rio, and the plea is not expected to have any ill effect on those plans.

The swimmer was contrite in court, with his attorney detailing his pursuit of sobriety since his arrest, including 45 days of inpatient treatment in Arizona. A letter from h saying he was forthright and cooperative.

Phelps' attorney, Steve Allen, told the judge that Phelps had already made tremendous progress, and is continuing with therapy in Maryland and has enrolled in Alcot "Mr. Phelps is a wonderful person," Allen said. "He's a gifted athlete, but he's also a person who gives back to the community. Mr. Phelps gets it: he gets what he did, He's had nothing but remorse for his mistake."

Documents show Phelps was stopped on Sept. 30 for speeding and crossing the double yellow line while driving in the Fort McHenry Tunnel. Police say Phelps regis alcohol test. The legal limit is .08 percent in Maryland.

Phelps, who was surrounded by his mother, sisters and friends, including former Baltimore Ravens linebacker Ray Lewis, addressed the judge and acknowledged his "I now have the tools to move past this. What I did was wrong, and I made a bad mistake. I'm looking forward to having a much brighter future than I had in the past," After pleading guilty to his first drunken driving charge in 2004, Phelps was sentenced to probation and required to talk to high school students about alcohol awarene charges, but as a young first-time offender he avoided conviction.

"I recognize the seriousness of this mistake," he said at the time. "I've learned from this mistake and will continue learning from this mistake for the rest of my life." Another embarrassment for Phelps came in 2009, when a British tabloid newspaper published a photo of him using a marijuana pipe at a party in South Carolina. Afte from USA swimming for three months and one of his major sponsors, Kellogg Co., dropped him.

Phelps has returned to training and a six-month suspension by USA Swimming ends on March 6. That will allow him to swim the final three events on the U.S. Grand seek to add some international meets to beef up his 2015 schedule, since he is also imposedbanned from swimming in next summer's world championships in Russia "We're looking at a lot of different options for competition," his coach, Bob Bowman, told The Associated Press in a recent interview. "We'll look at things in March and Phelps retired after the 2012 London Olympics but changed his mind a year later. Bowman said the swimmer was in much better shape, even after his DUI arrest and during his initial return to the pool.

Phelps won three golds and two silvers at one of the biggest meets of the 2014, the Pan Pacific Championships in August. He was named the male athlete of the yea As he walked down the steps of the Baltimore courthouse, Phelps said the past three months have been among the most difficult of his life.

"I'm finding out a lot about myself and for this day, I'm happy to be moving forward," Phelps said. "I'll continue to grow from this and continue on my path or recovery."

MDTA police confirm the 29-year-old swimming superstar was arrested around 1:40 a.m. Tuesday.

After an officer's radar clocked a 2014 white Land Rover on I-395 south going 84 mph in a 45 mph zone, the officer followed the car onto I-95 north and pulled it over J Tunnel toll plaza.

Police say Phelps was at the wheel and appeared to be under the influence. He was unable to perform satisfactorily on a series of field sobriety tests and was arreste excessive speed and crossing double lane lines within the Fort McHenry Tunnel on I-95 in Baltimore. He was later released.

MDTA police say Phelps was cooperative throughout his arrest.

On Tuesday afternoon, Phelps released a statement via Twitter, saying "Earlier this morning, I was arrested and charged with DUI, excessive speeding and crossing the severity of my actions and take full responsibility. I know these words may not have much meaning right now but I am deeply sorry to everyone I have let down."

This makes the second DUI arrest for the Baltimore Bullet.

Ten years ago, Phelps found himself in a similar situation.

The then 19-year-old swimmer was stopped near Salisbury University after running a stop sign. Salisbury Police charged him with DUI, DWI, violation of a license resign.

In that case, he took a plea deal, agreeing to 18 months of probation and to speak at schools about his mistake.

"I have already learned from this experience and will pass this along to others who even think about making the same mistake that I made," Phelps said in 2004.

When a photo of Phelps smoking from a bong at a college party surfaced in 2009, he faced no charges but was briefly suspended from USA Swimming and lost one: This time around, Phelps faces several charges.

Teammate Ryan Lochte commented on Phelps' arrest, telling TMZ that he should have hired a driver.

"He has so much money to get a driver. I even have a driver. Just stinks for the sport of swimming," Lochte said to TMZ.

It's been an interesting month for Baltimore athletes as the Ravens faced national criticism for how they handled former player Ray Rice's domestic dispute with his th City casino. After video obtained by TMZ showing Rice punch her in an elevator was made public, the NFL indefinitely suspended him.

Orioles slugger Chris Davis also made headlines recently as he was suspended for 25 games for testing positive for Adderall, a prescription drug that contains amphe Phelps has been training again for competitive swimming but has not confirmed whether he will compete in the 2016 Olympics.

The officers realized he was intoxicated and gave him a field sobriety test, authorities said.

Phelps has been charged with speeding, DUI and crossing double lane lines, police said. He has since been released, they added.

An indictment is merely a formal charge that a defendant has committed one or more violations of federal criminal law, and every defendant is presumed innocent unl The cases against Collins (Indictment 1), Lebarron et al (Indictment 3), Rice (Criminal Complaint), and Riley (Indictment 6) were investigated by the Drug Enforcement Secret Service, the Pinellas County Sheriff's Office, the Pasco Sheriff's Office, the Clearwater Police Department, the Pinellas Park Police Department, and the St. Pe part of an Organized Crime Drug Enforcement Task Force (OCDETF) investigation. The principal mission of the OCDETF program is to identify, disrupt, and dismantl and money laundering organizations and those primarily responsible for the nation's drug supply.

The cases against Fleer (Indictment 2), Lynch et al (Indictment 4), and Reed (Indictment 5) were investigated by Homeland Security Investigations and the Hillsborou of the Middle District of Florida's anti-opioid strategy to combat opioid trafficking and abuse.

USA Swimming announced today that, due to a violation of the organization's Code of Conduct, Michael Phelps (Baltimore, Md.) will be suspended from US competition for six months, withdraw from the 2015 FINA World Championships Team and forfeit his funding from the NGB for six months. (...) As a result, taken the following actions:

Withdrawal from the 2015 World Championship Team. Phelps and USA Swimming each agree that Phelps will not represent the United States at the 2015 Championships in Kazan, Russia, from August 2-9.

Forfeiture of USA Swimming's Monthly Stipend. The monthly payments from USA Swimming will be halted during the six-month suspension period.

'Membership in USA Swimming, and particularly at the National Team level, includes a clear obligation to adhere to our Code of Conduct. Should an infracti responsibility to take appropriate action based on the individual case. Michael's conduct was serious and required significant consequences," USA Swimmir Chuck Wielgus said. "Michael has publicly acknowledged the impact of his decisions, his accountability especially due to his stature in the sport and the stell improvement. We endorse and are here to fully support his personal development actions.'

M ichael Phelps' second DUI arrest the other day got me thinking about Hall of Fame quarterback Bobby Layne, another member of the Drinking and Driving Club – a attitudes toward such behavior have changed. In the '50s and '60s, when Layne was weaving down the road, an athlete getting pulled over was more likely to elicit ey condemnation being directed at Our Most Famous Swimmer. A different time, to say the least.

Like Phelps, Layne had multiple vehicular episodes — all coming not in his youth but toward the end of his career, when he was one of the most high-profile players in happen every other year:

A drunk driving arrest in Detroit in 1957, just before the season got underway.

Another DUI arrest in Austin. Texas, after a 1959 exhibition game.

And finally, an incident late in the '61 season in which he drove into a stopped street car in Pittsburgh.

Nothing came of *any* of these screw-ups. Not a blessed thing. Layne ran a bootleg on the legal system the first two times — details to come — and talked his way out boys-will-be-boys era in pro football, neither the league nor his teams (the Lions in the first instance, the Steelers in the other two) took any action.

You can imagine what the reaction would be today if, two weeks before the opener, a star quarterback was stopped at 2:10 a.m. for "traveling without lights . . . [and] refused to take a breathalyzer test, according to reports. But Bobby skated because no jury in Detroit was going to convict the home-team QB, not one who'd led the land so what started out with this . . .

- . . . and progressed to this . . .
- ... conveniently ended up like this:

All you need to know about this Great Moment in Jurisprudence is that, according to *The Associated Press*, "One woman juror, leaving the courtroom, remarked, 'Bol kiss for letting him off."

A few years later, Dave Lewis, the sports columnist for the Long Beach (Calif.) ${\it Independent}$, wrote:

After [Les] Bingaman quit playing for the Lions following the 1954 season, he bought a half-interest in a bar, which immediately became a financial success. When Layne was arrested on a drunk-driving charge a couple of years ago in Detroit, it developed during the trial that part of his tour that evening included Bingo gallantly took the stand and testified that the scotch he served had practically no alcoholic proof whatsoever, and he served it in glasses that measure After this was recorded in the newspapers, Doc Greene, one of Detroit's top scribes, observed: "Greater love hath no man than he should ruin his business

As for the DUI case in Austin, it was dropped when the county attorney couldn't get three key witnesses to voluntarily return to Texas to testify. (He couldn't subpoena only a misdemeanor.) The three witnesses, by the way, were Steelers teammate Len Dawson and two Cardinals players, all of whom were in Layne's car when he "st scene . . . and transferred to a taxicab," AP reported.

Bobby's lawyer suggested police officers "may have mistaken hoarseness for intoxication," the wire service said. That was pretty funny, because in the Detroit trial, hi mistook his *Texas drawl* for intoxication. (Which is it, barristers?)

The run-in with the street car also happened in the wee hours: 2:30 a.m. Even better, the car Layne was driving belonged to Steelers running back Tom Tracy. Anothe defensive lineman Ernie Stautner, once gave this version of the story to the *Pittsburgh Press*:

At Stautner recalled it, Layne got in the accident because he left a Thursday night "Last Supper" party at Dante's [restaurant, one of Bobby's favorite hango everyone else. In fact, coach Buddy Parker later criticized Stautner for not being with Layne at the time of the accident.

Police said Layne lost control of his car on the street car tracks, which were wet, and hit the front of the trolley. Whatever. Anyway, that Sunday, the Steelers finished in St. Louis, and Bobby — "playing with a patch over his left eye, which was cut in an auto accident last week," the *Pittsburgh Post-Gazette* reported — was terrible, the twice and contributing mightily to a 20-0 loss.

He'd entered the game with 187 career touchdown passes, tying him with Sammy Baugh for the NFL record. But because he was blanked by the Cards, it wasn't unti 15 — that he overtook Slingin' Sam, finishing with 196.

So ends the saga of Bobby Layne Behind the Wheel. But again, that was 50 years ago. In the 2000s, after two strikes, Michael Phelps might be left to twist in the winlike the Hoarseness Defense could be of much use to him.

Michael Phelps did not want to 'be alive anymore' after DUI arrest

Michael Phelps, the American swimmer whose 22 Olympic medals make him the most decorated Olympian of all time, has revealed that he was "in a really dark place for drunk-driving – and admitted to feelings of "not wanting to be alive anymore."

Phelps, who has 18 gold medals from three Olympic Games, describes his arrest and subsequent emotions in a revealing interview in Sports Illustrated, and recalls I as news media were camped outside. "I was in a really dark place," Phelps told SI. "Not wanting to be alive any more."

Shortly after his arrest, he entered a treatment facility in Arizona. He says his 45-day stint rejuvenated him, but at the time he felt frightened. "Hug-hug, kiss-kiss, turn s probably the most afraid I've ever felt in my life."

Phelps was pulled over in September 2014 after being clocked doing 84mph in a 45mph zone in Baltimore. He failed two sobriety tests and was charged with DUI, ex double lane lines. "I just put my head on the desk," his mother Debbie told SI. "I thought, Oh, my God, here we go again. How terrible is the world going to be to my sc Phelps's coach, Bob Bowman, echoed Debbie Phelps's concerns: "I had been living in fear that I was going to get a call that something had happened. Honestly, I the was going to kill himself. Not take his own life, but something like the DUI, but worse."

Phelps pleaded guilty to drunk-driving in December and was given one-year suspended sentence and 18 months of supervised probation, but avoided time. "The last some of the hardest times I've ever gone through," Phelps said on the courthouse steps after his hearing. "Some of the biggest learning experiences that I've ever had For this day, I'm happy to be moving forward, and I'll continue to grow from this. jail

"I look back now," says Phelps says in Sport Illustrated. "I lived in a bubble for a long time."

After the spell in rehab, Phelps got back in the pool. He returned to training last fall, and has worked hard to cultivate a leaner and more muscular physique. After bee the 2015 world swimming championships in Russia this summer, Phelps competed in the US nationals instead, and won gold in three events, in each posting the fast-He has not drunk alcohol since his arrest, and has vowed not to drink until the Rio Olympics are finished next August. After years of enduring workouts with a hangovi t had a single sip and will not have a sip. The performances were there because I worked, recovered, slept and took care of myself more than I ever had."

"I'm back to being the little kid who once said anything is possible," Phelps says in SI. "You're going to see a different me than you saw in any of the other Olympics."
