

New Jersey Man Sentenced to 3 Years in Prison for Fraudulently Obtainin Three Tom Brady Super Bowl Rings

SANTA ANA, California – A New Jersey man was sentenced today to 36 months in federal prison for posing as a former player for the New England Patriots, w family versions of the team's 2016 Super Bowl championship ring – supposedly as gifts to relatives of quarterback Tom Brady – one of which was sold at auction for r Scott V. Spina Jr., 25, of Roseland, New Jersey, was sentenced by United States District Judge David O. Carter, who also ordered Spina to pay \$63,000 in rest

player who sold him his Super Bowl ring and other memorabilia.

On February 1, Spina pleaded guilty to one count of mail fraud, three counts of wire fraud and one count of aggravated identity theft.

The scheme began in 2017, when Spina purchased a Super Bowl LI ring awarded to a Patriots player who subsequently left the team. Spina, who bilked the for with at least one bad check, sold the ring soon after for \$63,000 to a well-known broker of championship rings.

When Spina obtained the player ring, he also received the information that allowed the former player to purchase Super Bowl rings for family and friends that ar rings.

"Spina then called the Ring Company, fraudulently identified himself as [the former player], and started ordering three family and friend Super Bowl LI rings with each one, which he falsely represented were gifts for the baby of quarterback Tom Brady," according to court documents. "The rings were at no time authorized by Tc intended to obtain the three rings by fraud and to sell them at a substantial profit."

Spina entered into an agreement with the Orange County man who purchased the player's Super Bowl ring to sell him the three family rings that Spina now clai nephews. After agreeing to buy the three rings for \$81,500 – nearly three times what Spina paid for the rings – the buyer started to believe that Brady did not have ne from the deal.

The same day that the buyer tried to back out, and the same day that Spina received the rings in November 2017, Spina immediately sold them to an auction he auction in February 2018, one of the family rings was sold for \$337,219.

Spina admitted in his plea agreement that he defrauded the Orange County ring broker when he falsely claimed that the rings "were ordered for Tom Brady dire select family members." Spina also admitted that he defrauded this victim in relation to three wire transfers for the deposit on the family rings. Spina further admitted h posed as the former Patriot to purchase the rings.

The FBI's Art Crime Team investigated this matter.

Assistant United States Attorney Erik M. Silber of the Environmental and Community Safety Crimes Section prosecuted this case.

It also comes amid a class-action lawsuit filed in Florida against Curry, Brady and other celebrities — mostly high-profile athletes — which alleges that FTX had used scheme designed to take advantage of "unsophisticated investors." It also names FTX's former CEO Sam Bankman-Fried.

"Anyone who renders investment advice in Texas typically needs to be registered and they typically have to truthfully disclose all known material facts," said Joe Rotu enforcement director. "In Texas, there is not a different system of justice or regulation for people who are celebrities."

It's currently unclear if any prominent Texan would be investigated, but Rotunda said his team is still compiling a list of relevant parties based on recent court filings by III and the class-action lawsuit. In particular, it will be looking at what the promoters disclosed, how they were compensated and how their promotions were scripted an "It's important from a securities regulation standpoint, and from a bankruptcy standpoint, to determine the ways FTX was encouraging clients and Texans to use FTX He added that his team will also have to consider how the relevant law applies in this situation, since it was established via a 1985 case involving an investment and fi distributed via fax.

"That's a far cry from social media and broadcast advertisements, let alone tokens and blockchains, right?" Rotunda said.

Curry, Brady and FTX did not respond to the Tribune's requests for comment.

They are not the first celebrities to have been scrutinized or penalized for promoting crypto. Last month, Kim Kardashian agreed to pay the Securities and Exchange (regulator, \$1.26 million to settle allegations that she had hyped a crypto token on Instagram without informing the public that she received \$250,000 for the post. Ultimately, Rotunda said the scrutiny of celebrity endorsement is not his top priority, but the issue remains on his radar as his FTX inquiry continues. Beyond Texas, th numerous other state, federal and international investigations.

"Right now, we're trying to figure out how a \$32 billion company went to zero almost overnight," he said.

Tom Brady 's stolen jersey from this year's Super Bowl has been recovered after being found in the possession of a member of the international media, according to t The league announced Monday that the New England Patriots quarterback's game-worn jersey from Super Bowl LI and another jersey, missing from Super Bowl XLI> investigation led by the FBI.

The jerseys were found in Mexico and currently are being authenticated by authorities, Houston Police Chief Art Acevedo said.

Authorities recovered two Tom Brady jerseys, including this one, which he wore in Super Bowl XLIX, which was played on grass in Glendale, Arizona. *Mexican Attor.* The Mexican Editorial Organization (OEM), a major newspaper publishing company, has identified the man allegedly involved in the case as Martin Mauricio Ortega, newspapers, Diario La Prensa, until he resigned last Tuesday.

OEM announced in a statement Monday that it accepted Ortega's resignation, citing his previous mentions of family health issues, and said it had no previous knowle the case.

A Denver Broncos helmet, believed to belong to star pass-rusher Von Miller, from Super Bowl 50, also was recovered with the two Brady jerseys, sources confirmed currently are trying to authenticate the helmet.

A law enforcement source told ESPN that authorities used footage from Fox, which showed Ortega entering the locker room and, with his back to the camera, reachir jersey into a black plastic bag and leaving.

Authorities went over approximately 20,000 credentials, and eventually settled on Ortega as a person of interest, leading to Monday's announcement. A source also to stickers inside the helmet -- one each for the Army, Navy, Air Force and Marine Corps -- which led them to believe it belonged to Miller.

"I am happy my jerseys from SB 49 and SB 51 have been recovered, and I want to thank all of the law enforcement agencies involved. I know they worked hard on th appreciated. Hopefully when I get the jerseys back I can make something very positive come from this experience," Brady said in a statement released via his agent, Acevedo noted during a news conference Monday that the jerseys are in the possession of the FBI in Boston, and Iaw enforcement was working to authenticate them Acevedo mentioned a "suspect" in the case but did not say whether anyone was in police custody. He also tweeted about the recovery of the jerseys.

"Through the cooperation of the NFL and New England Patriots' security teams, the FBI and other law enforcement authorities, the Super Bowl LI jersey worn last mo recovered," the NFL said in its statement. "Also retrieved during the ongoing investigation was the jersey Brady wore in the Patriots' victory in Super Bowl XLIX again: "The items were found in the possession of a credentialed member of the international media. Due to the ongoing investigation, we would refer any additional question Following the Patriots' 34-28 victory over the Atlanta Falcons in Super Bowl LI, Brady immediately realized his jersey had been taken from a bag he had put it in in the "It's unfortunate, because that's a nice piece of memorabilia," Brady told the media a day later. "If it shows up on eBay or something, somebody let me know. I'll try to pretty special ones to keep. But what can you do? I'll take the ring. That's good enough for me."

A week later, Patriots owner Robert Kraft, on the Fox Business Network, compared taking the Brady jersey to "taking a great Chagall or Picasso."

In its report, the Houston Police assigned a value of \$500,000 to the jersey, the same number that sports auctioneer Ken Goldin, who has sold game-used Brady jers worth if it were to hit the open market. Game-used Brady jerseys from regular-season games have been sold in the \$50,000 range.

The Houston police classified the alleged theft of Brady's Super Bowl LI jersey as a first-degree felony. The Associated Press contributed to this report.

Ross delivered the joke while remembering the famous story of Brady walking into Kraft's office and telling him, "I'm the best decision your organization has ever mad applause, Ross delivered the punchline: "Would you like a massage?"

"Tom loves the roast. He's a student of the roasts," Ross stressed to Rich Eisen. "If you love the roast ... everyone wants to be the center of attention, even when their about him for three hours. MIAMI -- The NFL notified the Miami Dolphins on Tuesday that the team would be stripped of its 2023 first-round pick, among other disciplinary measures, for violatio integrity of the game.

Following a six-month investigation, the league found the Dolphins -- primarily team owner Stephen Ross and vice chairman/limited partner Bruce Beal -- violated the occasions from 2019 to 2022 in conversations with quarterback Tom Brady and the agent for then- New Orleans Saints coach Sean Payton.

The NFL, however, found no evidence that the team intentionally lost games during the 2019 season. In February, former Dolphins coach Brian Flores said in his law hiring practices that Ross attempted to incentivize him to "tank," or purposely lose games, shortly after he was hired in 2019, with Ross allegedly offering Flores \$100, Flores alleged that as the team won games late in the season, Dolphins general manager Chris Grier told him Ross was "mad" that the on-field success was "compro In addition to the first-round pick, the Dolphins also will forfeit their 2024 third-round selection.

Ross, meanwhile, was fined \$1.5 million and suspended through Oct. 17, during which time he isn't permitted to be at the Dolphins' facility or represent the team at ar any league meeting before the annual meeting in 2023.

Beal was fined \$500,000 and isn't permitted to attend any league meetings for the rest of the 2022 season.

Brady will not incur any punishment for the Dolphins' tampering, NFL league spokesperson Brian McCarthy told ESPN's Jenna Laine.

Beal spearheaded impermissible communications with Brady, then the New England Patriots ' quarterback, while he was still under contract; Ross and other Dolphins content of those conversations.

Both Ross and Beal tampered with Brady once again following the 2021 season, when he was under contract with the Tampa Bay Buccaneers . This time, however, t joining the team as a limited partner and possibly a football executive -- although the possibility of him playing for the team was discussed, according to the league's ir Finally, in January 2022, the NFL found that the Dolphins had "impermissible communications" with agent Don Yee -- who represents both Brady and Payton -- about head coach. The league found that the Dolphins "did not seek consent" from the Saints to begin these talks and that they occurred before Payton retired later that mo NFL commissioner Roger Goodell called the league's findings "unprecedented."

"The investigators found tampering violations of unprecedented scope and severity," Goodell said in a statement. "I know of no prior instance of a team violating the p head coach and star player, to the potential detriment of multiple other clubs, over a period of several years. Similarly, I know of no prior instance in which ownership violations."

Flores said in a statement that he was disappointed that Ross "will avoid any meaningful consequence" with Tuesday's discipline.

"I am thankful that the NFL's investigator found my factual allegations against Stephen Ross are true. At the same time, I am disappointed to learn that the investigator pressure to tank games especially when I wrote and submitted a letter at the time to Dolphins executives documenting my serious concerns regarding this subject at I in her possession," he said.
